THE VALUE OF CURRENCIES CHANGES EVERY DAY

The value of money is determined by its exchange rate. The value of the exchange rate - and therefore the currency - is affected by political changes, inflation, trade relationships, and more. Whenever there is a shift the value of your money changes.

HOW THE BIG BEAUTIFUL BILL RESHAPES THE FINANCIAL LANDSCAPE

In our most recent Lunch & Learn, we took a deep dive into the changes introduced by the "One Big Beautiful Bill Act." We explored what's been made permanent, what's changing, and where new opportunities are emerging.

Robert, AFI's resident tax strategist, kicked things off with a clear breakdown of what this bill does at the individual level. Key among the changes: many of the 2017 Tax Cuts and Jobs Act (TCJA) provisions (set to expire in 2025) have now been made permanent. This includes the lower marginal tax brackets, increased standard deduction, and the 20% Qualified Business Income (QBI) deduction for pass-through entities. Bonus depreciation was also locked in, providing long-term clarity for businesses making capital investments.

Robert also introduced new deductions that make Social Security income functionally tax-free for most retirees, along with temporary deductions for tip wages and overtime. A new type of savings vehicle was introduced for children born between 2025 and 2028. The accounts will be initially funded by the government and then allow for post-tax contributions and tax-deferred growth.

In the second half of the session, Peter shifted our focus to market strategy. The bill's economic ripple effects were laid out sector-by-sector, highlighting how changes in taxation and government spending will likely redirect capital flows.

Winners: Energy companies stand to gain from the removal of clean energy incentives that once favored their competitors. Industrial firms benefit from permanent bonus depreciation, which greenlights projects and accelerates ROI. Financials may enjoy a better lending environment as businesses ramp up spending, aided by long-term tax clarity.

Challenged Sectors: Healthcare providers face reduced federal funding from cuts to Medicaid and Medicare reimbursement structures. Utilities, while boosted by AI-driven electricity demand, lose ground due to withdrawn clean energy tax credits. Real estate may see pressure from higher long-term rates caused by the increasing national debt and new restrictions on foreign investor loopholes.

Finally, we highlighted actionable strategies for individuals: the next four years could present a golden window for Roth conversions and strategic asset sales. With tax rates stable and new deductions available, many clients can make tax-efficient moves today that reduce long-term exposure.

As always, these changes will take time to fully implement, and many of the IRS regulations and forms are still in development. While opinions on the bill will vary, what's undeniable is its broad impact across tax planning and investment decisions.
